Not only can we watch your tank for you, BUT you will also have the ability to monitor your tank by phone or tablet. Otodata has a special app that you will receive once you are enrolled. This is a wonderful option for those who travel, have a second home or for those who use propane for heating their pool, cooking and fireplace use. Those applications are often difficult to predict usage.

We are offering our Otodata monitoring program for a yearly fee of \$96.00.

## **Propane Tank Monitoring Terms and Conditions**

I agree to allow Surner Heating to install a tank monitor on the propane fuel tank at my property. Surner Heating agrees to survey the location and provide information for the physical conditions necessary to install and maintain the device.

I understand that at all times the monitor will remain the property of Surner Heating. Should I cease purchasing propane from Surner Heating, and switch supplier I will return the monitor to Surner Heating in a timely fashion. If I fail to provide Surner Heating with reasonable access to the tank during normal working hours, move without returning the monitor, damage the monitor in any way or simply refuse to return the monitor for any reason, I will be obligated to pay Surner Heating the purchase price of \$300.00.
